President Raymond Gilivancz called the Tierra Santa Board of Directors Meeting to order at 7:22 p.m.

Welcome: President Gilivancz welcomed the Board members.

<u>Approval of Minutes</u>: A motion was made, seconded, and carried to approve the March 13th, 2021 Board Meeting Minutes as presented.

<u>Treasurer's Report:</u> Eric Cavazos presented the March 2021 Treasurer's Report. March 2021 opened with a balance of \$186,339.08. Expenses of \$13,755.30 were paid and receipts of \$52,858.76 were deposited leaving a net balance of \$225,442.54 in the Operating Fund. The Reserve Fund balance was \$179, 461.44 resulted in a combined balance of \$404,903.98.

A motion was made, seconded, and carried to approve the Treasurer's Report as corrected.

Finance Report: Eric Cavazos presented that APRIL 2021 financial results. Both Revenues and Expenses are as expected and on budget. The 2021 Dues collection rate as of the end of March is 70%(approximated). Expenses were slightly under budget for a second month.

A **motion** was made, seconded, and carried to approve the Financial Report as presented.

No update was available on delinquent properties or foreclosure activities.

Committee Reports

Property Manager's Report:

Sean Richey is approved to receive month-to-month training on Quickbooks to improve administrative skills. Mr. Juan will assist at the end of April to train Sean on operational knowledge of quick books

Sean Richey needs an updated laptop. A **motion** was made, seconded, and carried to approve the purchase of a Chromebook laptop (not to exceed \$400) for use by the Property Manager. This will give faster load times on a newer model. Old Laptop donated to guards for Wiseview app access

Sean Richey reported that he had received five resale certificates for the month of March.

Sean discussed the Gate repair. Texas Gate exit repair would be completed on 12 April.

Sean presented the board with playsets design option from Rainbow Playsets. A **motion** was made, second and carried to approve the purchase a playset for under \$10,000

Building and Grounds:

Dennis Slavin proposed a plan and quote for Lighting for the island along north entrance of Tierra Santa. Item tabled for May meeting

Dennis Slavin proposed a plan to install a sprinkler system near the south side of the playground. A **motion** was made, second and carried to approve the purchase of the sprinkler system

Dennis Slavin Proposed a Boulder/landscape to prevent 9th hole traffic from transgressing on residents lots

Dennis Slavin Proposed a quote for "sealcoating" Tierra Santa Blvd. Item tabled for May meeting

Quote for Wall Painting and for dead Bugamdia removal. \$3,500 for removal, \$3,000 for painting. A **motion** was made, second and carried to approve the purchase for \$5,700

Adrian announced future concert. Johnny Lee and Mark Chestnut will perform on May 15th. Emaill will be sent to residents.
