<u>Treasurer's Report:</u> Eric Cavazos presented the July 2021 Treasurer's Report. July 2021 opened with a balance of \$340,859.81. Expenses of \$16,218.46 were paid and receipts of \$3,734.87 were deposited leaving a net balance of \$138,715.81 in the Operating Fund. The Reserve Fund balance was \$179,666.90 resulted in a combined balance of \$318.382.71.

A motion was made, seconded, and carried to approve the Treasurer's Report as corrected.

<u>Finance Report</u>: Eric Cavazos presented that July 2021 financial results. Both Revenues and Expenses are as expected and on budget. The 2021 Dues collection rate as of the end of June is 80%(approximated).

A **motion** was made, seconded, and carried to approve the Financial Report as presented.
